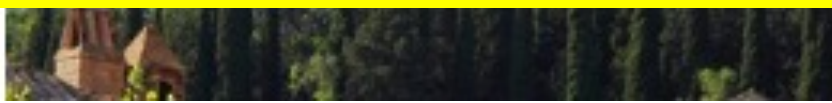
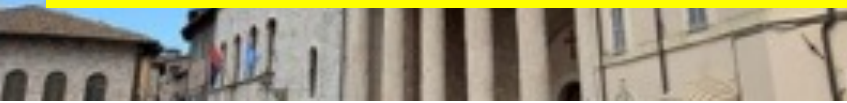

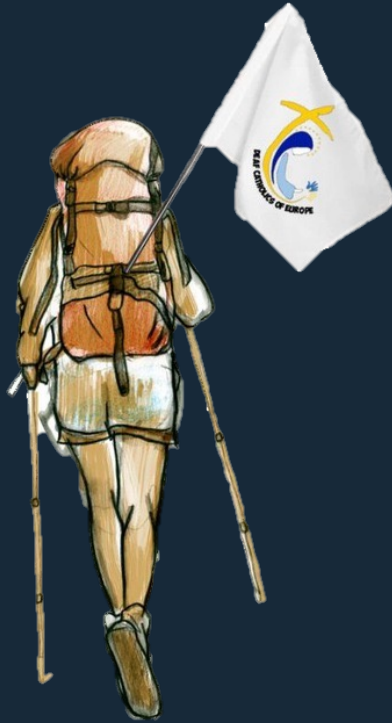

Terms and conditions of surface transport:

Services will be provided using all types of coaches (Gran Turismo, shuttle buses, etc.) driven by qualified drivers.

The coach will be in good condition at departure.

Any damage caused by passengers during the journey will be the responsibility of the group.

The journey must be made according to the previously agreed itinerary and mileage; any changes or increases in

mileage must be communicated and may result in changes to the price. The company may refuse to authorise changes

to the characteristics of the journey if these prevent compliance with current EEC regulations on driving and rest

periods for drivers.

In this regard, please note that, in a 24-hour period, the driver may drive for a maximum of 9 hours and must rest for at

least 11 hours; therefore, the daily working time may not exceed 13 hours.

GENERAL CONDITIONS:

All passengers (including children) must have valid personal and family documents, and travellers must check that their passport, visa and/or national identity card meet the requirements of the country they are visiting. The traveller is responsible for obtaining a passport or any other requirement for entry into each country, as well as obtaining the corresponding visas and/or authorisations, including transit through third countries, all in accordance with the pre-contractual information provided by the organising agency and retailer.

If the documentation is rejected by any authority or entry into the country is denied due to failure to meet the requirements or due to not having the documentation, this will not be considered a 'cancellation due to force majeure' and the agency will not be responsible for any additional expenses nor will it refund the price of the trip. Minors under the age of 18 must carry a written permit signed by their parents or guardians and issued by the competent authority, in case it may be requested by any authority. Minors and infants must carry their national identity card or passport, as well as other documents if necessary.

Ground Transport Terms and Conditions:

Services will be provided with various types of buses (touring coaches, shuttles, etc.) driven by qualified drivers. The bus will be in good condition at departure.

Any damage caused during the trip by passengers will be the responsibility of the group. The trip must follow the agreed itinerary and mileage; any change or increase in mileage must be communicated and may result in price changes. The company may deny authorization for modifications that violate EU regulations regarding driver hours and rest.

Within a 24-hour period, the driver may drive a maximum of 9 hours and must rest at least 11 hours; thus, the daily workday cannot exceed 13 hours. For multi-day trips, the driver's meals and accommodation will be at the group's expense.

Group Cancellation Policy:

A 30% non-refundable deposit of the total group cost is required upon booking. Up to 45 days before hotel arrival, all rooms may be canceled except for the non-refundable deposit. From 45 days before arrival, cancellations incur fees.

The number of rooms may be reduced as long as the group has a minimum of 43 pilgrims.

Any variation in the number of pilgrims may lead to price adjustments.

A rooming list is required 40 days before arrival.

Due to limited availability of single rooms, it is necessary to report the required number as early as possible.

INTERNAL COMPLAINT PROCEDURES

The traveller may submit the corresponding complaint in writing to the organising agency.

DATA PROTECTION

In compliance with Organic Law 3/2018, of 5 December, on the Protection of Personal Data and Guarantee of Digital Rights, and European Regulation 2016/679 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, IAG7 Viajes, the retail agency and the traveller undertake to respect and comply with current regulations in this area.
